

**Godkendelse af transportklassifikation for fyrværkeri**  
*Approval of transport classification for fireworks*

Med henvisning til særlig bestemmelse 645 i ADR-konventionen godkender Sikkerhedsstyrelsen hermed transportklassifikationen for den nedennævnte artikel.

*With reference to special provision 645 of the ADR agreement the Danish Safety Technology Authority hereby approves the transport classification for the below mentioned article.*

Gyldigheden ophører dog kun, hvis sådanne nye kriterier indikerer en anden end den ovenfor angivne transportklassifikation. Sikkerhedsstyrelsen kan til enhver tid forlange artiklen prøvet i henhold til prøvningsserie 6 i *United Nations Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria* til dokumentation for korrekt klassificering.

*The transport classification has been approved on the basis of the information provided by the applicant concerning the article. The approval is valid until Danish Safety Technology Authority implements new criteria for default classification or criteria for default classification is introduced in the ADR. However, the approval remains valid if such new criteria do not imply a transport classification different from the one indicated above. Danish Safety Technology Authority may at any time require the article to be tested according to Test Series 6 in the United Nations Recommendations on the Transport of Dangerous Goods, Manual of Tests and Criteria in order to prove the classification .*
